Here, for your interest and consideration, are some examples of the services within the funeral plans we offer, but please remember we can include further options to personalise the plan to fully reflect your requirements.

## Example of a Simple Funeral Plan

**£2,865**

A simple funeral plan may include:

- Removal of the deceased during office hours only.
- Guidance on the registration of the death.
- Care of the deceased in accordance with the wishes of the family, including facilities for viewing in our Chapel of Rest during office hours only.
- Attending to all the necessary arrangements and providing the funeral director, driver and bearers for the funeral service.
- The supply of a plain basic coffin suitable for burial or cremation.
- Supply of a hearse to meet the family at the nearest crematorium or cemetery.
- Disbursement costs to cover the usual cremation and clergy fees, or a contribution towards burial costs, are included in the price of this plan (please see the note on disbursements for further details).

These services take care of the essential funeral costs, allowing your family further scope to personalise your funeral service as required at the time.

## Many people choose a Standard Funeral Plan which, in addition to the essential services, includes:

**£3,265**

- Removal of the deceased at any time of day or night.
- Providing facilities for viewing by the family at the funeral director's premises, including preparation and dressing in a suitable gown or own clothes if required.
- The supply of a quality wood veneered coffin suitable for burial or cremation.
- Supply of a hearse and one limousine - the cortège can leave from a local address and proceed to the local crematorium or place of burial.
- Receiving flowers for the funeral, or charitable donations in lieu of flowers, and providing a list of donors to the relatives or executors.
- Disbursement costs to cover the usual cremation and clergy fees, or a contribution towards burial costs, are included in the price of this plan (please see the note on disbursements for further details).

## A more Personalised Funeral Plan might include:

- Horse-drawn hearse.
- Provision of two or more limousines.
- A church service followed by burial in the local cemetery or churchyard.
- A coffin of your choice from our extensive range.
- Printed 'Order of Service' sheets.
- Contribution towards placing death announcements in either national or local newspapers.
